For DRE related cases, an additional \$250 fee will apply to the Case File Analysis & Phone Consultation Service.

For Felony related cases, an additional \$250 fee will apply to any of the below Pre-trial Services.

Case File Analysis & Phone Consultation: Fee: \$750

- Provides a thorough review and analysis of the case file.
- Provides a verbal opinion of the driver's vehicle operation, physical manifestations, and performance on the SFSTs and any Divided Attention Techniques.

Case File Analysis & Written Report: (Not Available for DRE Cases) Fee: \$1000

- Report includes specific cites to NHTSA DWI/SFST student manual and any relevant studies.

Case File Analysis & Comprehensive Written Report: (DRE Cases Only) Fee: \$1350

- Provides a breakdown and explanation of the DRE's administration of the 12-step evaluation.
- Provides an analysis of the DRE's final opinion.
- Report averages approximately 30 pages based on information given to analyze.
- Report includes specific cites to IACP/NHTSA DRE student manual and any relevant studies.

Civil Cases - Case File Analysis, Expert Reports & Consultation

A \$2000 retainer is required in all civil cases prior to any pre-trial services provided. Unless otherwise noted below, all services provided in civil cases prior to trial are billed at the hourly rate of \$250/hour.

Court Appearance & Depositions (Criminal & Civil Cases)

Receipt of the court retainer is required prior to reserving a specific date exclusively for the Firm and prior to the Firm announcing the engagement of the Expert to the Court or Opposing Counsel. Prior to receiving the court retainer, Impaired Driving Specialists, LLC reserves the right to accept other court appearances, even if a specific court date has been previously discussed. Once a specific court date has been reserved for the Firm or once the Firm has announced the engagement of the Expert to the Court or Opposing Counsel, the court retainer fee is *non-refundable*.
