## CURRICULUM VITAE

### EXECUTIVE SUMMARY

I am the founder, Chief Executive Officer, and Certified Senior Court Video Specialist with Digital Evidence Legal Video Services, a full-service legal video and litigation support firm specializing in audio and visual evidence solutions.

During the month of September 2021, I celebrated my 45<sup>th</sup> year as an audio and video expert. I am court qualified to provide expert testimony in courts of law relative to complex audio and video evidence.

I am appointed by State and Federal Courts to assist trial counsel by conducting forensic audio and video evidence analysis, and to enhance audio and video evidence during criminal matters in California.

The Criminal Division of the Superior Court of the State of California, Los Angeles County appointed me to its Panel of Expert Witnesses in 2009.

I was a member of the Forensic Expert Witness Association from 2009 to 2013, and my firm has been approved by the State Bar of California as a Provider of MCLE Accredited Activity.

Prior to founding Digital Evidence in 2001, I was employed as a television cameraman, film and videotape editor, remote broadcast technician, television producer and director from 1976 to 2006.

For 30 distinguished years, I videotaped and edited news stories, produced and directed award-winning documentaries, and high-profile investigative segments for ABC, NBC, CBS, FOX, and WB Television Networks and their affiliates. During my tenure with the networks, I was required to enhance video signals and audio frequencies on a daily basis for television broadcasts.

I am the recipient of 2 Golden Mic Awards, presented by the Radio and Television News Association of Southern California. As a Director of Photography with the Fox Television Network, I was nominated for an Emmy Award in the category of “Best Videography on a Breaking News Story.” Throughout my television career, broadcast industry administrators repeatedly cited me for providing superior technical services.

During my tenure with the powerhouse ABC-owned-and-operated television station KABC-TV in Hollywood, California, my exemplary camera work helped the network win an *Emmy Award* for “Best Live Coverage of a Breaking News Story.”
